

# NOTICE OF ELECTION

## UK Parliamentary election for the West Worcestershire constituency

1. An Election is to be held for a Member of Parliament to serve the West Worcestershire county constituency.
2. Nomination papers can be obtained from the offices of the Acting Returning Officer, Room F7, Council House, Avenue Road, Malvern, Worcestershire, WR14 3AF, during the times stated below or by downloading a copy from [www.malvern hills.gov.uk/elections](http://www.malvern hills.gov.uk/elections)
3. Nomination papers must be delivered to the Acting Returning Officer, Room 2, Council House, Avenue Road, Malvern, Worcestershire, WR14 3AF on any working day after the date of this notice between the hours of 10am and 4pm but no later than **4pm on Friday, 7 June 2024**.
4. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as banker in the United Kingdom. Bank payments should be paid into the MHDC Receipts Account – sort code 404717 and account number 02292785. The payments need to quote reference 9912/8903 and the candidate name and political party (if any). Debit or credit card payments can be made via <https://www.malvern hills.gov.uk/pay-it>. Select the Miscellaneous option from the list and then Parliamentary Election Candidate Deposit. Include candidate name and political party (if any).
5. If any election is contested the poll will take place on **Thursday, 4 July 2024**.
6. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Tuesday 18 June 2024**. Applications to register can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote)

New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote arrangements must reach the Electoral Registration Officer at Electoral Registration Officer at Room F7, Council House, Avenue Road, Malvern, Worcestershire, WR14 3AF by **5pm on Wednesday, 19 June 2024**.
