Hallow NDP Business Survey Report

Business Survey

Method:

In May 2018 a leaflet was distributed to businesses in the parish of Hallow, notifying recipients that Hallow Parish Council was developing a Neighbourhood Development Plan, explaining the purpose of the NDP and inviting business recipients to complete an on-line questionnaire. A significant number of businesses contacted operate out of the two business parks at "Hallow Park" and "Elgar". Both were visited by leaflet droppers, and the businesses spoken to if they were available. Recipients were given 2 weeks to complete the survey on-line, with a closing date set at 30th June 2018. (The on-line link was also published in the Community Questionnaire that went to every household in the parish.)



Business Survey Leaflet

Responses:

Some 43 businesses where contacted, including farms, retail outlets, and a wide range of commercial and community services. A total of 15 responses were received, representing a healthy 35% return on those businesses directly contacted (but the responses could also include residents working from home who were alerted to the Business questionnaire via the publicised link in the Community questionnaire).

Because of relatively small number of recipients and respondents to the business survey, it is not appropriate to present results as percentages. Please take extra care when interpreting the results.

Please note that for Questions B1, B3 and B14, respondents could select more than one answer to a particular question.

B7: Do you have any other comments on jobs and the local economy?

There were four comments as follows;

- 1. No
- 2. Hallow is too far from motorway for large scale employment, has negligible unemployment and high working from home rates. Tourism is generally low waged creates environmental problems and any increase should be discouraged
- 3. New govt development funding ,employ quota o FC as school leavers and new retired poor.
- 4. someone who works from home, a café (maybe community café) in the village with wifi would be great to enable home workers to interact with people and not feel isolated. As an aside, I've always felt that a community café would be a great thing for Hallow for the large numbers of elderly people we have who can be a bit isolated due to the lack of regular buses and stay-at-home parents as well as us home workers.

B8: What would help your business to develop and thrive during the next 5 years?

There were **nine** comments made as follows:

- 1. Promoting shopping locally
- 2. Public transport to attract apprentices/university interns. We have had a number not apply to us due to our location (Elgar Business Centre). One current apprentice's granddad has to bring him to work and pick him up every day!
- 3. Sufficient good office parking. Flexible term office with all services included, Reduction in cost of rent and rates
- 4. faster broadband and mobile networks
- 5. not a lot, I'm heading for retirement
- 6. Parking & local transport
- 7. Sponsorship, bank partnership, or govt funding.
- 8. Improved internet
- 9. My business could be based from a home or office anywhere so no local factors aside from broadband, phone connection and being accessible to couriers are relevant.

There were **four** comments as follows:

- 1. We moved our premises out of Hallow in 2016 owing to a lack of small business units available to purchase in either Hallow or Worcester. We are now commuting to a unit we bought in Bromsgrove.
- 2. It would be good to have access to flexible term office space with all necessary services installed at reasonable cost
- 3. There are no freehold employment properties in the village at present.
- 4. Insufficient facility or support

B10: Are there any planning constraints or local barriers that will or may prevent your business from developing during the next 10 years?

There were five comments made as follows:

- 1. Advertising constraints
- 2. No (5 comments)

- 3. Yes, because the planning system does not support new employment development outside of the development boundary for the village. There are no sites within the village.


