Proposed Neighbourhood Green Space at Hayslan Fields Malvern

I have written in the past, objecting to any building taking place on Hayslan fields. It is very disappointing to learn that it is again being considered for development as many plans, dating back as far as 1981, have been consistently refused.  In 2016 SWDP formally adopted with the SWDP Inspector's Report highlighting Hayslan fields as a good example of Green Space in private ownership and the energing plan of Nov 2018 submitted it as such. Every judgement has been in support of it being part of a Green Corridor right up to the present day, Why is it therefore in the Dec 2018 NewCall for sites with the Owners submitting the site for development? Itrust that Hayslan Fields and any other Green Space with Similar credentials will continue to be safeguarded and not included in potential development as part
of the recent call for sites.  The SWDP carried out an in depth review of Green Space requirements and the findings were adopted only a
short time ago. I believe it would be a waste of resource to repeat this exercise now. Please continue to protect all currently designated green space.
