I feel object 8 skims over the issue of a lack of childcare places for the 0-2s, as a local parent I had to travel to Worcester for childcare for my baby. Currently the pre-school only accepts children from the age of 2. There is a severe shortage in the area for provision for the 0-2s – the preschool could be expanded to become more of a 'full service 0-4' nursery alongside a bigger primary school in the future. This is a plan for the next 15 years after all.
