Kempsey Lawn Tennis Club welcomes Policy K10B which would provide much needed additional space for overall sport and recreation within the village. However, in line with Policy K10A, Kempsey Lawn Tennis Club is strongly in favour of retaining, safeguarding and improving its facilities at The Playing Fields site.
Whilst Kempsey Lawn Tennis Club has no desire to move to a new site off Pixham Ferry Lane or for any duplication of tennis related facilities, we would welcome the provision of a suitable indoor facility that would be large enough to facilitate coaching sessions for the Club's younger players during winter months, given the lack of such facilities within the village at the present time.
With the provision of additional space at the proposed site off Pixham Ferry Lane, Kempsey Lawn Tennis Club would welcome the opportunity to expand its current facilities at The Playing Fields, including through the provision of an additional fourth floodlit court.
